

## Instructions for signing

Thanks for choosing Farewill. There are a few important steps you need to take to make your will legal.

- STEP 01. Print your will, read it through carefully and make sure you understand it. If there's something you want some help or advice with, don't hesitate to get in touch: [legalteam@farewill.com](mailto:legalteam@farewill.com).
- STEP 02. Once you're happy with your will and understand its contents, you need to find two "witnesses" to watch you sign your will and then sign it themselves. Witnesses should be over 18 years old, not a beneficiary of your will (or married to a beneficiary), and someone you know and trust.
- STEP 03. Get together with your witnesses. You sign it (in pen) first, with both witnesses watching. Each witness then prints their full name and signature.
- STEP 04. Store it somewhere safe and let your executors know where it is.

# Last Will And Testament Of Sarah Jenkins

I Sarah Jenkins born on June 4th 1982 hereby revoke all former Wills and testamentary dispositions made by me and declare this to be my last Will.

## Preliminary Declarations

- 1 I make this Will in expectation of my marriage or civil partnership to Hugo Marshall & I direct that this Will shall not be revoked by that marriage or civil partnership.
- 2 I have the following living children: Toby Jenkins born on 03/12/2015 and Holly Jenkins born on 17/09/2011.
- 3 I wish to be cremated.
- 4 I have included an Appendix to this my Will which is not a testamentary document but has been placed with this Will to assist my Trustees in preparing my funeral, finding my financial assets and delivering personal messages I have written to my beneficiaries.

## Executors and Trustees

- 5 I appoint as my executor of this my Will Brian Jenkins of brian@brianmedia.com.
- 6 I appoint as my trustees those of my executors who obtain a Grant of Representation for this Will and in this Will the expression 'my Trustees' means those of my executors who obtained a Grant of Representation and the trustees for the time being whether original substituted or added of any trust arising under this Will.

## Guardians

- 7
  - a Where my child Toby Jenkins is still a minor and I am the sole surviving parent at the time of my death I appoint Brian Jenkins of brian@brianmedia.com to be their guardian.
  - b Where my child Holly Jenkins is still a minor and I am the sole surviving parent at the time of my death I appoint Brian Jenkins of brian@brianmedia.com to be their guardian.

## Pet Guardians

- 8 a Where my pet Benson is alive and healthy at the time of my death I appoint Hugo Marshall of 7 The Spires, SE11 2XJ to be their guardian.
- 9 If any pet of mine is suffering or beyond reasonable treatment where my executor or executors are unable to place that pet with a guardian for any reason I direct my executors to have my pet euthanised as soon as practicable.
- 10 All costs relating to the care treatment and euthanasia of my pets in the period immediately following my death and prior to adoption by a permanent guardian will be paid out of the residue of my estate.
- 11 For any other pet that I own at my death or where any appointed caretaker cannot afford or refuses to accept the responsibilities of ownership for any pet of mine then I give my executors the fullest possible discretion in the placement of that pet in an alternate permanent safe and loving environment as soon as possible.

## Specific Gifts and Legacies

### Specific Bequests

- 12 The specific gifts given by this Will shall be paid free of inheritance tax and other taxes or duties payable as a result of my death and the cost of delivering any gift to a beneficiary or vesting it in them shall be an executorship expense as shall be the cost of the upkeep of the gift until delivery or vesting.
- 13 Any item that fails to pass to a beneficiary will return to my estate to be included in the residue of my estate.
- 14 a I give to Holly Jenkins born on 17/09/2011 my 'My Grandmother's Wedding Ring'.
- b I give to Brian Jenkins of brian@brianmedia.com my 'Photo albums'.

### Pecuniary Legacies

- 15 The pecuniary legacies given by this Will shall be paid free of inheritance tax and other taxes or duties payable as a result of my death.
- 16 Any pecuniary legacy that fails to pass to a beneficiary will return to my estate to be included in the residue of my estate.
- 17 a I give £1500 to Toby Jenkins born on 03/12/2015.

## Residuary Estate

- 18 I give devise bequeath and appoint all my estate not otherwise disposed of by my Will or by any codicil to my Will to my Trustees upon trust to use it to pay my debts funeral and testamentary expenses and the legacies bequeathed by my Will or by any codicil to my Will and all tax and other fiscal impositions payable on or in respect of my estate or any part thereof as a result of my death and to divide my residuary estate among the following in the shares specified:
- a To Hugo Marshall of 7 The Spires, SE11 2XJ: 90%.
  - b To Stonewall registered charity number 12444: 5%.
  - c To Macmillan Cancer Support registered charity number 124: 5%.
- 19 If any of the persons named in clause (18) dies before me leaving a child or children living at my death then such child or children shall take in equal shares the share of my residuary estate which their parent would otherwise have inherited.
- 20 If any of the gifts set out in clause (18) fails it shall be added proportionately to the gifts which do not.
- 21 The receipt of a person who appears to be a proper officer of a charity shall be a discharge to my Trustees.
- 22 If at my death any of the above charities has amalgamated with another charity my Trustees shall pay its share to the amalgamated charity.
- 23 If at my death any of the above charities has ceased to exist my Trustees shall pay its share to the charitable organisation or organisations the objects of which they in their absolute discretion consider most closely resemble the objects of the charity which has ceased to exist.
- 24 In determining the shares set out above my Trustees shall

only make a gross division so that only the shares which are not exempt from inheritance tax shall be reduced by any inheritance tax attributable to them.

## **General Provisions**

- 25 The standard provisions and the following special provision of the Society of Trust and Estate Practitioners [2nd Edition] shall apply:
- a Minors and beneficiaries without capacity: powers over trust capital.
